# 6. New Mexico State University - \$855,000 Baseball Training Facility Upgrades - REVISED

Ms. Heather Watenpaugh presented the project remotely. She introduced herself and notified the committee that this project had been approved by the NMHED during the October hearing. She also noted that NMSU requested that the project be pulled from the SBOF agenda due to a scope change from a prefabricated structure to a steel structure built on site.

Chairman Burke noted that the revised submittal is missing the donation agreement from the original submittal.

Chairman Burke asked if the demand was truly that high in that area of the state for cosmetology.

Mr. Hardin informed the committee that part of the students in the program enrollment numbers are dual-credit. It is expected that there will be an increase in the number of college students however the high school student enrollment will remain the same. He also noted that many of the students that enroll at NMJC come from west Texas and the surrounding areas. All of these students receive certificates.

Member Suazo asked how old the estimates are. Member Hoehne followed up the question and asked if NMJC was confident in the estimated costs.

Mr. Hardin informed the committee that they are extremely confident in the estimates. He also noted that they have been working closely with Decker Perich Sabatini throughout the design.

Mr. Tom Neale introduced himself and Ms. Erica Richards. Mr. Neale and Ms. Richards then presented the project as outlined in the project submittal. Ms. Richards noted that UNM completed an assessment which provided them information on the need for a family medical facility in Sandoval County.

Member Hoehne asked that a copy of the assessment be provided to the committee.

Chairman Burke asked what the cost to renovate this facility would be.

Mr. Neale noted that the corridor width standard for medical facilities as required by the Department of Health is 60" and this clinic only has a 56" corridor width. Correcting these corridors and doing other small renovations to the facility will cost about \$200K.

Member Hoehne asked what level of services will be provided at this facility.

Ms. Richards noted that the facility will be a family medicine clinic with five providers who will be able to provide services to approximately 95 patients per week.

Chairman Burke made a motion to approve the project for submittal to the Cabinet Secretary and then to the State Board of Finance contingent upon receipt of the assessment requested by Member Hoehne.

Ms. Marbury informed the committee that this upgrade to piping is not part of the Phase II scope of work, will not be funded using the Phase II appropriation, and is necessary in order to allow for Phase II renovation of this space.

Member Rommel asked why the piping is being replaced when it was only recently installed.

Ms. Marbury noted that the piping installed for lab drainage use was a CPVC material which was thought to meet the requirements for lab drainage. During the first year the piping began to

experience failures. UNM is in the process of investigating the issues, including assistance from their General Counsel on getting this addressed with the supplier. In order to prepare for Phase II and not cause any delays UNM is requesting approval to replace the piping now while the investigation continues.
