AGREEMENT FOR TERMINATION OF LEASE AND CONVEYANCE OF ASSETS

This Agreement for Termination of Lease and Conveyance of Assets is made between the Regents of the University of New Mexico ("University") and the University of New Mexico Tennis Foundation, a New Mexico nonprofit corporation ("Tennis Foundation").

WHEREAS, the University is lessor and the Tennis Foundation is lessee of certain real property in the South Campus of University (the "Property") under a lease dated April 5 and 6, 1977 (the "Lease"), upon which real property the Tennis Foundation has erected tennis courts and a tennis clubhouse (the "Improvements"); and

WHEREAS, the Tennis Foundation is indebted to the University on a promissory note dated February 1, 1981 ("the Note"), in the total amount of \$172,000.00, representing principal in the amount of \$172,000.00 and unpaid interest to December 31, 1986, of \$91,580, which Note is secured by a Security Agreement covering the Lease and the Improvements, together with all equipment, supplies, machinery and accounts belonging to the Tennis Foundation (the "Security Agreement"), which Note is currently in arrears; and

WHEREAS, pursuant to Paragraph 16 and the Lease, the parties desire to terminate the Lease and convey the Improvements and all other assets and personal property of the Foundation covered by the Security Agreement University in lieu of foreclosure of the Security Agreement.

THEREFORE, the parties agree as follows:

- 1. The Lease is hereby terminated by mutual agreement of the parties and is no longer of any force or effect.
- 3. Title to all personal property and assets as listed on Exhibit ${\tt A}$, is hereby conveyed to the University.
- 4. In exchange for termination of the Lease and conveyance of the Improvements assets of the Tennis Foundation, the University hereby cancels the indebtedness represented by the Note and hereby terminates the Security Agreement securing such indebtedness.
- 5. The University will execute and file a release of lien reflecting payment of the Note in full and cancellation of the Security Agreement.
