- D. Cable TV for the installation, maintenance, and service of such lines, cable, and other related equipment and facilities reasonably ecessary to provide Cable services.

included, is the right to build, rebuild, construct, reconstruct, locate, relocate, change, remove, replace, modify, renew, operate and maintain facilities for purposes described above, together with free access to, from, and over said easements, with the right and privilege of going upon, over and across adjoining lands of Grantor for the purposes set forth herein and with the right to utilize the right of way and easement to extend services to customers of Grantor for the purposes set forth herein and with the right to utilize the right and privilege to trim and remove trees, shrubs or bushes which interfere with the purposes set forth herein.
