## NUMBER FOUR

A certain parcel of land situate within the City Limits of the City of Albuquerque, New Mexico and being identified as an Easterly portion of Lots numbered Twelve (12) and Thirteen (13), together with the vacated alley in Block numbered Six (6) of Country Club Addition, an Addition to the City of Albuquerque, New Mexico, as the same are shown and designated on the Plat of said Addition, filed in the office of the County Clerk of Bernalillo County, New Mexico, on June 7, 1923, and being more particularly described by metes and bounds survey as follows:

Beginning at the Northeast corner of the parcel herein described, said Northeast corner being the Northeast corner of above mentioned Lot 13, Block 6, and the point of intersection common to the Southerly line of Ash Street, NE with the Easterly line of existing University Boulevard, NE; thence,

Northeasterly, 223.55 feet distance along said Easterly line of widened University Boulevard, NE, along the arc of a curve bearing to the left (said arc having a radius of 1,574.50 feet and a chord which bears N.  $13^{\circ}04'10''$  E., 222.61 feet distance to a Point of Tangency; thence,

N.  $09^{\circ}00'00''$  E., 34.83 feet distance continuing along said Easterly line of widened University Boulevard, NE to the Northwest corner of the parcel herein described, said Northwest corner also being a point on the Southerly line of Ash Street, NE; thence,

S.  $81^{\circ}12'00''$  E., 35.00 feet distance along said Southerly line of Ash Street, NE to the Northeast corner of the parcel herein described and place of beginning.

## NUMBER FIVE

Wagner's Replat of Block numbered Thirty-four (34) of Brownell and Lail's Highland Addition to the City of Albuquerque, New Mexico, as the same are shown and designated on the Replat of said Addition, filed in the office of the County Clerk of Bernalillo County, New Mexico, on April 14, 1943, and being more particularly described by metes and bounds survey as follows:

Beginning at the Southeast corner of the parcel herein described, said Southeast corner being the Southeast corner of above mentioned Lot A-10, Block 34, and the point of intersection common to existing Westerly line of University Boulevard, NE with the Northerly line of Tijeras Avenue, NE; thence,

N.  $81^{\circ}02'00''$  W., 11.78 feet distance along said Northerly line of Tijeras Avenue, NE to the Southwest corner of the parcel herein described, said Southwest corner being a point on curve on widened Easterly line of University Boulevard, NE; thence,

Northeasterly, 89.03 feet distance along said widened Easterly line of University Boulevard, NE along the arc of a curve bearing to the right (said arc having a radius of 1,468.50 feet and a chord which bears N.  $16^{\circ}03'53''$  E., 89.01 feet distance) to a Point on Curve, said Point on Curve being the most Northerly point of the parcel herein described and a point on existing Westerly line of University Boulevard, NE; thence

S.  $08^{\circ}29'00''$  W., 89.10 feet distance along said existing Westerly line of University Boulevard, NE to the Southeast corner of the parcel herein described and place of beginning.

Beginning at the Southeast corner of the parcel herein described, said Southeast corner being the Southeast corner of Lot numbered Ten (10) and the point of intersection common to the Westerly line of existing University Boulevard, NE with the Northerly line of Copper Avenue, NE, thence,

N.  $81^{\circ}02'00''$  W., 19.50+ feet distance along said Northerly line of Copper Avenue, NE to the Southwest corner of the parcel herein described, said Southwest corner being a point on the Easterly line of widened University Boulevard, NE; thence,

N.  $08^{\circ}58'00''$  E., 222.75 feet distance along said Easterly line of widened University Boulevard, NE to a Point of Curvature; thence,

Northeasterly, 77.25 feet distance continuing along said Easterly line of widened University Boulevard, NE along the arc of a curve bearing to the right (said arc having a radius of 1,468.50 feet and a chord which bears N.  $10^{\circ}22'20''$  E., 77.24 feet distance) to a Point on Curve, said Point on Curve being the Northwest Corner of the parcel herein described and a point on the Southerly line of Tijeras Avenue, NE; thence,

S.  $81^{\circ}02'00''$  E., 17.50+ feet distance along said Southerly line of Tijeras Avenue, NE to the Northeast corner of the parcel herein described, said Northeast corner being the Northeast corner of aforementioned Lot 5 and the point of intersection common to said Southerly line of Tijeras Avenue, NE with the Westerly line of existing University Boulevard, NE; thence,

S.  $08^{\circ}58'00''$  W., 300.00 feet distance along said Westerly line of existing University Boulevard, NE to the Southeast corner of the parcel herein described and place of beginning.

on the 26th day of August, 1889, and more particularly described by metes and bounds survey as follows:

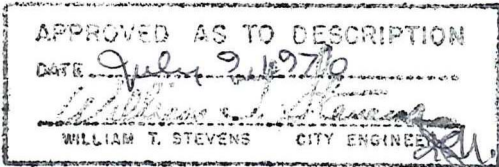

S. 08°58'00" W., 277.00 feet distance along said existing Westerly line of University Boulevard, NE to the Southeast corner of the parcel herein described; thence,

N. 81°02'00" W., 23.00 feet distance to a Point of Curvature; thence, Northwesterly, 23.56 feet distance along the arc of a curve bearing to the right (said arc having a radius of 15.00 feet and a long chord which bears N. 36°02'00" W., 21.21 feet distance) to a Point of Tangency, said Point of Tangency being a point on the Easterly line of widened University Boulevard, NE; thence,

N. 08°58'00" E., 262.00 feet distance along said Easterly line of widened University Boulevard, NE to the Northwest corner of the parcel herein described, said Northwest corner being a point on the Southerly line of Copper Avenue, NE; thence,

S. 81°02'00" E., 20.0+ feet distance along said Southerly line of Copper Avenue, NE to the Northeast corner of the parcel herein described and place of beginning.
