BEGINNING at the Southeast comer of the parcel herein described, a #4 rebar and cap set, being a point on the Westerly Right of Way line of University Boulevard, N.E., from whence the ACS Monument "NDC-22-1A" beers N75*42'34"E, 741.63 feet distant, Thence leaving said Right of Way line, N81*19'42"W, 258.73 feet to the Southwest comer, a #4 rebar and cap set, Thence S81*19'04"E, 741.17 feet to the Northeast corner, a #5 rebar found, being a point on said Westerly Right of Way line; Thence along a curve to the right, having a radius of 1,989,86 feet, a central angle of 06"22'40", a chord S07"23'24"E, 208,03 feet, an arc length of 208.14 feet to the Point of Beginning.
