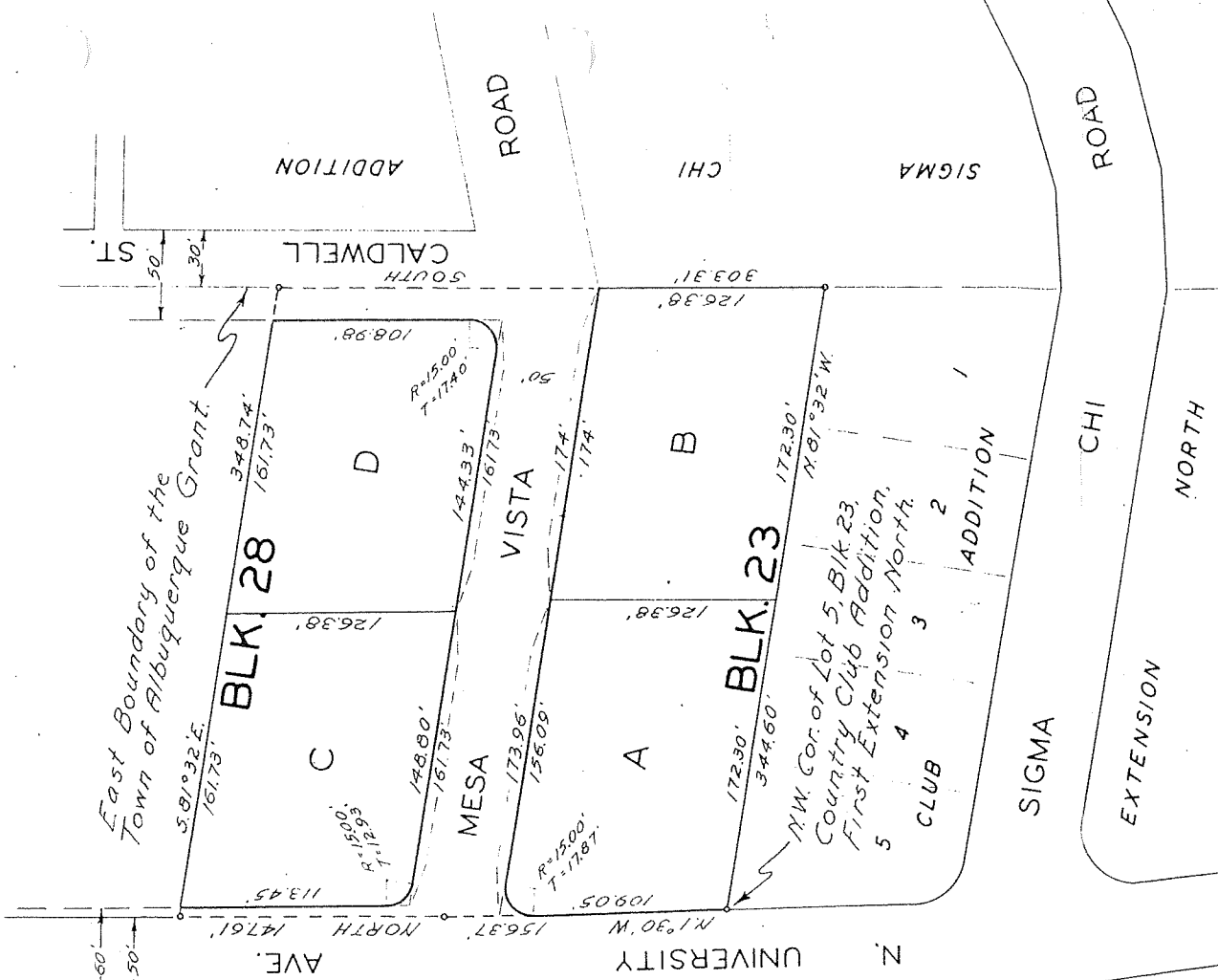

The foregoing subdivision of that certain tract of land situate in the City of Albuquerque, New Mexico, and more particularly described as follows: Beginning at the Southwest Corner No. 1, being the identical Northwest corner of Lot numbered Five (5) of Block numbered Twenty-Three (23) of Country Club Addition, First Extension North, as shown and designated on the plat of said Addition filed in the office of the County Clerk of Bernalillo County, New Mexico, on the 16th day of May, 1938, running thence N. 1°30'W. 156.37 feet, along the Easterly line of North University Avenue, to corner No. 2; thence North 147.51 feet, continuing along the Easterly line of North University Avenue, to the Northwest corner No. 3; thence leaving said line of University Avenue and running S. 81°32'E. 346.74 feet to the Northeast corner No. 4, a point on the Easterly boundary of the Town of Albuquerque Grant; thence South 303.31 feet, along said Grant boundary to its intersection with the Northerly boundary of said Country Club Addition, First Extension North; thence N. 81°32'W. 344.60 feet along said Northerly boundary of said Country Club surveyed and subdivided as the same appears hereon, comprising Lots A & B, of Block numbered 23, and Lots C & D, of Block numbered 28, together with a portion of Mesa Vista Road and including additional rights of way of Caldwell Street and North University Avenue, all of COUNTRY CLUB ADDITION, ALBUQUERQUE, NEW MEXICO, is with the free consent and in accordance with the date of the undersigned owner and proprietor thereof.
