Huber has a ground lease on the Property pursuant to that certain Lease dated February 1, 1955, and recorded on March 4, 1955, in Book D307, beginning at Page 463, in the real property records of the County Clerk of Bernalillo County, New Mexicowith The Regents of the University of New Mexico, as Lessor and Sarah D. Huber and William H. Huber, as Lessee.
- 3. The Agreement obligates Huber to assign to the University all of Huber's right, title and interest, as tenant, in and to the Lease.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and conditions contained herein, Huber and the University agree as follows:

1. <u>Assignment</u>. Huber grants, assigns, sets over and transfers to the University all of Huber's right, title and interest as tenant or lessee in, under and/or

- 2. <u>Acceptance of Assignment</u>. The University hereby accepts this Assignment and expressly acknowledges and agrees Huber has no responsibility pursuant to the Lease for matters first arising after the date of this Assignment.
- 3. <u>Further Assurances</u>. The parties shall promptly execute and deliver any additional documents which are reasonably necessary to evidence or better effect this Assignment.
- 4. <u>Counterparts</u>. This Assignment may be executed in counterparts by each party, each of which when delivered shall be deemed an original and all of which taken together shall constitute one instrument.
- 5. <u>Governing Law</u>. This Assignment shall be deemed to be an agreement made under the law of the State of New Mexico and shall be governed by and construed in accordance with such law.
- 6. <u>Binding Effect</u>. This Assignment shall be binding upon and inure to the benefit of each of the parties and its successors and assigns.
- 7. <u>No Merger</u>. It is the intention of Huber and the University that no merger or termination of any interests occur. It is the intention that the lessor's interest pursuant to the Lease not merge with the lessee's interest pursuant to the Lease. It is also the intention that none of the following interests merge with the fee interests in the Property:
  - A. The lessor's interest pursuant to the Lease;
  - B. The lessee's interest pursuant to the Lease; and/or


